

Sebi disposes of notice against former FTIL official

New Delhi, 2 May

Markets regulator Securities and Exchange Board of India (Sebi) on Thursday disposed of show-cause notice against Parthiban Vaidyalingam, a former official of MCX, NSE and FTIL, after charges of insider-trading could not be established. This follows Sebi revoking interim orders against many individuals, including Vaidyalingam, after alleged violation of some other provisions of insider trading rules could not be proved against them.

It was alleged in the notice filed last December that Vaidyalingam, being an insider, before the outbreak of SEL, irregularities avoided issues by selling 3,000 shares of FTIL on November 16, 2012 when in possession of unpublished price sensitive information.

- The Board recommends a final dividend of Rs 0.60 (60%) per share on equity shares of the Company making a total dividend of Rs. 1.00 (100%) per share including interim dividend declared earlier.
- The Company has adopted Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Companies Act, 2013, read with the relevant rules issued thereunder, from April 1, 2016 being the date of transition as per Ind AS 101.
- The published financial results for the quarter and year ended March 31, 2017 have been restated by the management for presenting the operations of the consumer electric business undertaking as discontinued operation (up to February 28, 2017) consequent to the Scheme of Arrangement as stated in Note 5 and adoption of Ind AS as stated in Note 2 above.
- Remuneration paid to the Managing Director of the Company during the financial year ended March 31, 2016 had exceeded the limit prescribed under Section 197 read with Schedule V of the Companies Act, 2013 by Rs. 177.70 lacs. The Company has filed application to the Central Government for waiver of such excess remuneration. This has been referred to by the auditors in their audit report for the year ended March 31, 2018 as a matter of emphasis.
- Pursuant to the Scheme of Arrangement (the 'Scheme'), duly sanctioned by the National Company Law Tribunal, Kolkata Branch, vide Order dated November 9, 2017 (the 'Order') with effect from the Appointed Date i.e. March 1, 2017, the consumer electric business of the Company stands transferred to the newly formed company namely "Orient Electric Limited". The scheme has been considered in these results by transferring the carrying amount of assets and liabilities pertaining to the consumer electric business with effect from the Appointed Date pursuant to the aforesaid Order.

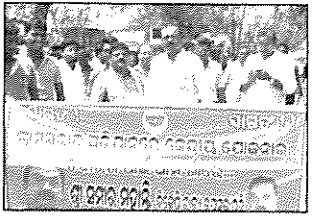

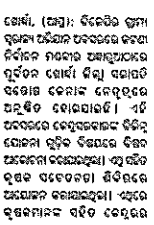
