Notice is hereby given that the Securities and Exchange Board of India vide its Circular No. SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97 dated July 2, 2025 ("**Circular**") has facilitated mechanism for a "**Special Window for Re-lodgement of Transfer Requests of Physical Shares**" and accordingly all physical share transfer deeds lodged for transfer with the Company or its Registrar and Transfer Agent ("**RTA**") prior to discontinuation of physical mode of transfer, i.e., April 01, 2019 and rejected/returned by the Company/RTA due to deficiency in the documents and was required to be re-lodged with requisite documents on or before the cut-off date fixed for re-lodgement of such transfer deeds, i.e., March 31, 2021; shall be provided with an opportunity to re-lodge the same with the Company/RTA during a special window period of six months from **July 07, 2025 till January 06, 2026**.
